- 4. Sealed quotation must be submitted to Office of the Dean, Faculty of Science and Technology, Pokhara University, Pokhara-30, Kaski, Nepal by hand on or before 12:00 hours of Falgun 04, 2077 (16/02/2021). Bids received after the deadline of the submission will be rejected.
- 5. Sealed quotation will be opened in the presence of the bidder's representatives who choose to attend at 2:00 P.M. on Falgun 04, 2077 (16/02/2021) at Faculty of Science and Technology, Pokhara University, Pokhara-30, Kaski, Nepal. Sealed quotation must be valid for a period of 45 days after sealed quotation opening. All quotation must be accompanied by a **Bid Security Amount NRs. 40,000/-** which shall be valid for 75 days after opening of sealed quotation. Bidders are advised to furnish a bid security from "A" class commercial bank.
- 6. If the last day for purchasing, submission and opening falls on a government holiday, the next working day shall be considered as the last day.
